G. OLD BUSINESS

- Review condition of Calwa's Community Hall air conditioner with possible solutions on repairs or replace and direction to Staff.
 Item removed from agenda; presenter was unable to make the meeting. Felix is going to get quotes from AC companies for a new AC unit.
- Consider Report on Calwa Park Swimming Pool Project including Phase I: Construction of New Swimming Pool and Amenities and Phase II: Abandonment of the Current Pool and adopt Resolution approving the Report and authorize staff to move forward with implementation including the execution of necessary agreements – District Administrator (A)

Steve Rapada from Sal Quientero's office came to present along with Ari Martinez, Lou Brossi and Mike Kludjian on the swimming pool project. A meeting was held to bring the total cost of the swimming pool down so that it could be kept in same location as it is in now, but the deep end will be now filled in with dirt. Pool equipment room will be relocated and original will be turned into storage. Bathrooms and showers will be renovated by Mark with the CMG company. Outside showers were approved by environmental health department.

New swimming pool size is going to be 44' x 88'. The shallow end of the swimming pool will be rebuilt. Kaiser Permanente has extended their grant deadline until May of 2020 and was willing to work with us on a month to month basis extension if needed. Steve Rapada stated that they had a total of \$191,000 cash from sponsor's or committed donations. JD Foods are talking to Steve Rapada about donating to help cover the cost of maintenance for the swimming pool once it was built. \$285,000 is the commitment from Fresno County towards to the swimming pool project and that it won't cost Calwa Park anything.

Approval of resolution passed with corrections to swimming pool project. Motion made by Board Member Jose Luis Sanchez and Seconded by Board Member Gabriela Mares. 4-0 approved and 0-opposed.
